- All non-cash payments made for tickets must be received by 3:00 PM on October 13, 2008.
- If an entrant's check or credit card is dishonored or found to be otherwise invalid by the bank or credit card company, the ticket(s) will be void unless the Tecumseh YMCA receives full payment by 3:00 PM on October 13, 2008. The Tecumseh YMCA shall have full discretion to decline any payments made by an entrant if any of the entrant's prior payments have been dishonored or found to be otherwise invalid.
- The Tecumseh YMCA agrees to pay up to \$2,000.00 of the sales tax pertaining to the vehicle. The winner shall have the responsibility to pay any sales tax in excess of \$2,000.00, and all other licensing, luxury, income, special taxes, and/or other costs associated with the vehicle and the transfer of its title.
- The winner shall be responsible for all shipping and/or transportation costs of the vehicle after the drawing. Additionally, the winner shall be responsible for all vehicle storage fees after the drawing.
